Braveheart Chaplain Ministry is growing! My name is Chris Messenger & I'm the new Assistant Chaplain for Braveheart. I hail from Kansas City and my wife, Amy grew up in a small town in northwest Montana. We moved our lives to Kalispell, Montana to live close to Amy's roots and where I have fallen in love with chopping firewood and exploring the woods on snowshoes. I have worked in various ministry settings in the last 15 years and have a Master of Divinity degree from Midwestern Seminary in Kansas City. I am currently working on my second Masters Degree in Pastoral Care & Counseling from the Antiochian House of Studies. In addition to being an emergency responder chaplain for the Kalispell Police & Fire Department, I am a hospice chaplain with Frontier Hospice. I am also a portrait photographer, a musician, and I spend time actively involved in my parish, St. Herman's Orthodox Church.

My movement into a part-time role with Braveheart has been a dream of Drew & I for the past 15 months. As of February this year, the board members have voted to officially bring on an assistant chaplain in a paid role.

It's easy for Drew & I to see God's perfect timing for this role since the number of serious first responder calls is growing rapidly in the Flathead. Even as I write this, my phone is lighting up with concerns/follow-up to a difficult event the night before.

I have hit the ground running with my emergency responder chaplain work. My most immediate work is spending time with Kalispell Police & Fire & overseeing the Braveheart volunteer chaplains. If you know Drew well, then you realize he is an extremely busy man & constantly on the go while helping build this chaplain ministry. My position along with the volunteer chaplains allows Braveheart to have a more consistent presence within all the different departments of the Flathead Valley's first responders. Every week consists of me doing a ride-along with both KPD & KFD. Additionally, I am coordinating our volunteer chaplains to start gathering on a monthly basis so we can grow both in our chaplain work & as a team. As a testament to Braveheart's impact within law enforcement over the years, the county even provided me with a decommissioned vehicle to in order to get around the county for my work. I joke with Drew that we even have a growing Braveheart vehicle fleet!

It brings me an immense amount of joy to work with Drew & the Braveheart Board in an official capacity. Its common for people to give me a half smile & a nod when I tell them I work part-time as an emergency responder chaplain as their brains try to comprehend what it is to be a law enforcement chaplain. If I only have the time to response in a sentence, I always say, "We are there for the first responders when they need us & at a moments notice, we are there for every member of the community on some of the toughest days of their lives."

What a gift. On behalf of Drew & myself, thank you to each person reading this letter for the multitude of ways you support us. We have needed help spiritually, emotionally, & financially to provide this ministry to our community & its first responders, and you have been there continually supporting us in the many ways that you do. THANK YOU! If the first 3 months of 2021 are any kind of forecast for the rest of the year, it's indeed going to be a busy one. Please pray for us as we come to mind & pray that Braveheart Chaplain Ministry will continue to serve our community both for God's glory & for the good of Flathead County. May God bless you.


